INTRODUCING THE SPEAKER

PP Susan Tu from R C Cheras introduced the guest speaker PP Robin Tay who presented a talk on the subject "Rotary Walks To End Polio."

SPEAKER'S CV

PP Robin Tay joined Rotary in 1986. He became President in 2009 after 23 years of service in Rotary.

Robin is active in the District. Served as District Rotaract Chairman, District End Polio Chairman, District Fund Raising Chair for Walk/Jog/Run/Wheel - A - Thon which was just concluded yesterday at Padang Merbok, KL.

Since he joined, Polio Plus (it was known then) was already one of Rotary International most prominent humanitarian projects. It was due to the Bill & Melinda Gates Foundation, the US \$200,000 Challenge in RY 2009 that inspired me to do something extraordinary in the name to end polio.

The birth of the 1st Rotary Walks To End Polio was from Alor Setar to Kuala Lumpur in 15days. It was initiated by 3 Presidents and 3 Friends of Rotary. Then at mid-way, 1 Past President and 15 Rotaractors from D3310 participated for 6 days and they walk vigorously from Penang to Ipoh during Christmas Eve.

On the last of the walk, it was graciously joined by many Rotarians and Rotaractors who have walked more than 20km from Sri Hartamas to Sheraton Hotel, Subang, where the RI D3300 District Conference was held. A total of US\$30,000 was raised for End Polio.

In RY 2010, the 2nd Rotary Walks To End Polio, was from Kuala Lumpur to Singapore in 11 days. This time 3 Past Presidents together with 17 Rotaractors from National University of Singapura took part. The walk was very adventurous and most memorable till today. This walk raised US\$100,000.

In conjunction with the Rotary International Convention in Bangkok in RY 2012, due the inundated great flood which hit Northern Thailand and Bangkok badly during the months of October 2011 until January 2012, the 3rd Walk which was supposed to be from Ayutthiya (The Ancient City of Thailand) to Bangkok didn't materialise.

Instead, the Trans-Sabah Walk from Sandakan to Kundasang, 8 days of walk then climb Mt. Kinabalu and then down the gunung and walked again to Kota Kinabalu was carried out. Those 11 days of more than 500km walk and climb was indeed a real endurance challenge to a human body and spirit.

Seven Past Presidents and an ex-Rotaractor took the challenge and only two Rotarians made it to the end.

One vomited profusely on the 2nd Day and another was

suspected to have a mild stroke on the 3rd Day. Anyway, this didn't deter the rest of the walkers to stop. Nevertheless, at the finish line at Jesselton Pier more than 500 Rotarians, Rotaractors, Friends of Rotary, Family Members etc graciously came and join in the walk. With their untiring effort, they raised US\$100,000 at the opening of RI D3310 District Conference held at Sutera Habour, KK.

In total to-date, these three walks have raised US\$230,000 for RI End Polio to match Bill & Melinda Gates Foundation.

Well, in conclusion, if everything goes well as planned, the 4th Rotary Walks To End Polio will begin from 3rd May to 13th May 2014. This walking expedition will start from Singapore to Johor Bahru, then to Kota Tinggi, to Mersing, to Endau connecting to Rompin to Pekan then to finish line at Kuantan. A total of 10 days 350km walk with one rest day along the nice white sandy beaches along the East Coast.

Philippines Typhoon Aid Begins Transition to Long Term Recovery

MANILA — The latest tallies of the human toll from Typhoon Haiyan are a daunting preview of the challenges ahead. Thirteen million people have been affected, four million of them displaced, and one million homes have been destroyed. Meanwhile, 2.5 million individuals now rely on food aid and around 7,000 people have been confirmed as dead or still missing.

President Benigno Aquino had set a target of "zero casualties" as the storm bore down on the Philippines, but as the country reeled in the first few chaotic days after the storm, the government came under criticism for not doing enough to assess the extent of the devastation and get aid moving.

Many people may have had the impression "the government was not doing anything" for the first few days, acknowledged presidential spokesman Edward Lacierda in a VOA interview.

"We are an archipelago," said Lacierda, a member of the cabinet of President Aquino. "We had to make sure that everything was done in the proper way, not to mention the fact that really this storm surge, the effect on Tacloban was quite huge and devastating."

Corruption Concerns for Recovery Effort

As parts of the country turn to rebuilding, Philippine and international agencies say that the emergency tempo of the relief effort in the central part of the country will need to continue for 18 months.

There are concerns that the Philippines' notorious corruption could skim off resources and hamper the long-term recovery. However, President Aquino has made fighting graft a focus of his administration and hopes to reassure donors with top-level oversight.

Just three government agencies will handle all of the donated funds, and high ranking officials, including Lacierda, will track spending and publish accounting reports online.

SOME EXPLANATORY NOTES ON THE STANDARDIZATION OF "VOCATION" AND "CORE ACTIVITIES" FOR THE CLASSIFICATION LIST (RY 2013/2014)

Vocation

Generally, three categories of classification have been adopted by the Club over the years as follows:

Category 1	Classification based on "vocation" or "profession" wherein the "vocation" or "profession" (accountancy, advertising, auditing, dentistry, education etc.) itself is explicitly identified, with the various services relating to the "vocation" or "profession" indicated as core activities.
Category 2	Classification based on the type of "product" (agricultural products, alcoholic beverages, automobiles, building materials etc.) wherein the "product" is stated under "vocation", with the various services relating to the "product" indicated as core activities.
Category 3	Classification based on the type of "establishment/industry/organization" (government, army, navy, police, university, hospital, hotel, transport etc.) wherein the "establishment/industry/organization" is stated under "vocation", with the services or sub-sectors relating to the establishment/industry/organization indicated as core activities.

The above categorization is not comprehensive nor absolute, and some "vocations" in Category 1 overlap with the "core activities" in Category 2. For example "Trading" and "Manufacturing" are identified as "vocations" in Category 1, and these are identified as "core activities" in some of the "vocations" identified in Category 2. There are also some "vocations" which do not fit in any of the above three categories, and are included on their own merits.

"UNFILLED" CLASSIFICATIONS

A close look of the so-called "unfilled" classifications in the Classification List reveals that these "unfilled" classifications are no more than an accumulation of the classifications over the years of the previous Rotarians who have left the Club. It is unlikely that new members will strictly fall under one or any of these "unfilled" classifications. Perhaps therefore, it would be more meaningful for the Club to create newly named activities to replace the old core activities to suit the new candidates' profiles as and when new members join the Club. The old list will nevertheless then serve as a useful historical record for reference of the Club's diversity of classifications which the Club may wish to preserve.

Dear Presidents and Rotarians

This is a reminder that all Rotary Clubs will have to select their Electors for the 79th District Conference

MOP 2010 Para 15.050.1 Electors:

"Each club in a district shall select, certify, and send to its annual district conference at least one elector. Any club with a membership of more than 25 shall be entitled to one additional elector for each additional 25, or major fraction thereof. of its members. That is, a club with a membership of up to 37 members is entitled to one elector, a club with 38 to 62 members is entitled to two electors, a club with 63 to 87 members is entitled to three electors and so on. Such membership shall be determined by the number of members in the club as of the date of the most recent semiannual payment preceding the date on which the vote is to be held. However, any club whose membership in RI has been suspended

by the board shall not be entitled to any electors. Each elector shall be a member of the club. An elector must be present at the district conference to vote"

Please note that the Credentials certificate that must be presented, together with proof of payment of District Dues and RI semiannual dues, by the Electors to the District Credentials Committee on Saturday, 14 December 2013 between 2.30pm to 4.30pm at the District Conference venue.

ROTARY FRIENDSHIP EXCHANGE

n interesting Rotary program of fellowship is the Rotary Friendship Exchange. (RFE.) This activity is intended to encourage Rotarians and their families to visit Rotarian families in other parts of the world. It may be conducted on a club-to-club basis (individual Rotarians and their families) or district to district (4-6 Rotary couples) basis.

The RFE program was officially adopted in 1988 by RI after a successful pilot experiment. The idea is for several Rotarians to travel to another country. Later, the hospitality is reversed when the visit is reciprocated. The RFE is frequently compared to the Group Study Exchange (GSE) program of the Rotary Foundation, except that it involves Rotarian couples or families who personally pay for all expenses of their inter country experience. Doors of enduring friendship are opened in a way that could not be duplicated except through Rotary.

A RFE team from District 3300 led by AG Rema Paul and spouse Rtn Ole Spooner (RC Greater KL) leaves for District 3040 (India) on 25 Nov 2013 on a two week program covering Indore and Bhopal with a stopover in Mumbai. Among the team members are PP Baskaran and Syamala (RC Butterworth), PP Rajendran and Selvi (RC Damansara), Rtn Susheela and spouse Palani (RC Melawati) and PP Premjit Gill and Begum Zainal Abidin (RC Damansara).

In addition, there will be various team building activities including special **Zumba** and **Akido** sessions to keep all participants fully occupied throughout the 5 days and 4 nights.



WORLD POLIO DAY 2014

Attn: Rotary Directors, Trustees, DGs, DGEs, RPICs, RRFCs, and RCs

Dear Rotary Leaders,

Rotarians around the world celebrated World Polio Day, **24 October**, with events to raise both awareness and funds for polio eradication. The tremendous amount of activity included the illumination of high profile landmarks with the *End Polio Now* message in India, Brazil and Mexico; a bike-a-thon involving local celebrity ambassadors in Nigeria, and the launch of a *speaking book* project promoting immunizations in Pakistan. In India alone, more than 30 landmarks across the country were illuminated with the *End Polio Now* message, receiving strong media coverage.

RI also convened a special program, <u>World Polio Day:</u> <u>Make History Today</u>. The event, co-hosted by the Northwestern University Center for Global Health, was held in downtown Chicago and broadcast live online to a global audience.

Speakers included President Ron Burton; Dr. Robert Murphy, director of Northwestern's Center for Global Health; Dr. Bruce Aylward, the top polio eradication official at the World Health Organization; Dennis Ogbe, a polio survivor, Paralympian, and ambassador for the United Nations Foundation's Shot@Life campaign; and Emmy award-winning actress Archie Panjabi, a Rotary polio celebrity ambassador.

The Livestream event, in English only, helped carry our polio eradication message to a new audience and is now archived for continued viewing. Several of the speakers' remarks, in English only, also are available for download individually, so that Rotarians can use them for club meetings and other events.

- Viewers in 15 countries (including Ukraine, Brazil and South Africa) tuned in for the live broadcast
- The live and archived video of the event had more than 11,000 views in just five days.
- More than 1,000+ people tweeted about World Polio Day: Make History Today

More than 31,000 people liked, commented or shared Facebook posts about the event

A significant amount of media coverage was generated on World Polio Day 2013, including articles focusing on Archie Panjabi and her work with Rotary on Windy City Live and Huffington Post Live, an interview with Dr. Aylward in the Journal of the American Medical Association, as well as coverage in the Voice of America, Radio France International, Pakistan Today, Die Welt, Wall Street Journal's India Real Time, among others.

If you haven't already, I encourage you to watch <u>World Polio Day: Making History</u> and share it, along with the <u>World Polio Day infographic</u>, with others. And please start thinking about creative ways Rotary clubs can build off of our success this year and make World Polio Day 2014 an even more effective platform to carry the *End Polio Now* message.

Pakistan tribal elders in talks to free polio workers

Tribal elders in Pakistan's north-western Khyber region are reportedly negotiating with suspected militants to release kidnapped polio workers.

The workers, said to be four teachers involved in a polio vaccination scheme for schoolchildren, were taken from a school in the Bara area.

Polio vaccination workers are often targeted for kidnap by militants, accused of being Western spies or part of a plot to sterilise Muslims.

Polio remains endemic in Pakistan.

This is partly due to militant resistance to polio vaccination campaigns, say correspondents.

A senior government official in Bara told the AFP news agency that the group behind the kidnappings was <code>Lashkar-e-Islam</code>. "Tribal jirga has started negotiations with <code>Lashkar-e-Islam</code> people," the official said. "We are hopeful for the early release of polio workers."


