INTRODUCING THE SPEAKER

PP Richard Liew introduced the guest speaker PP Tan Sri Dato' Soong Siew Hoong who presented a talk on the subject "My Rotary Journey."



SPEAKER'S CV

Speaker: PP Tan Sri Dato Soong Siew Hoong¹

PP Tan Sri Dato' Soong was born on December 1925 in Kuala Lumpur and educated at the Methodist Boys' School and Technical College, KL.

The Tan Sri was managing a family business in the manufacturing of machineries for rubber and palm oil processing factories since 1950.



Presently he is a Director of 2 public listed steel manufacturing companies. He was also an elected State Assemblyman for Petaling Jaya from 1978 to 1986 (two terms) and later appointed as a Senator for one term. He has held various positions as Secretary General of the Chinese Chamber of Commerce for over 20 years; an Executive Advisor and Chairman of International Trade and Industry; Council Member of FMM and Chairman of SMI Working Committee for over 30 years.

SPEAKER'S TEXT

The original name of our club was "Rotary Club of KL South" which was eventually changed to "Rotary Club of Pudu." It was then an all men's club. We were under R I District 330 which comprises seven countries.

A few years after our charter in 1966 the late PP Douglas Fraser recommended to us to organise a District Conference in May 1969.

Back in the 1960's to make up at a meeting we had to drive to Rawang or PJ in order to have a 100% attendance. It was through the weekly luncheon talks that my personal knowledge was enriched.

Through the fellowship and friendship established through Rotary, I have been long term friends with many Rotarians.

Besides playing an active role in Rotary, I have served as an Assemblyman, Senator and Secretary General of the Chinese Chamber of Commerce. At the Chinese Chambers I have also encouraged Community Service.

In my 47 years as a Rotarian I have observed that some Rotarians are RINO – "Rotarians In Name Only" and TONFU – "Talk Only No Follow Up."

We must also create interesting programmes and projects to cater to various interests of the members. Retention is equally as important as Recruitment.

Our service to the community must come before our personal interests.

1. Tan Sri Dato' Soong has been a Chartered Member of the Rotary Club of Pudu for 47 years.

RESOLUTIONS ADOPTED AT THE 79TH D3300 CONFERENCE ON 15 DECEMBER 2013

1. Resolution on the District Assembly and District Training

Whereas:

1. In order to support and strengthen clubs, the provision of relevant Rotary training and leadership development is vital. Accordingly, there is a need to look at the structure and content of district training, particularly at the District Assembly. The dwindling attendance at District Assemblies is an indication that the Rotarians at not interested and involved in the district training events.
2. The District Assembly is described in the MOP as follows:
“Purpose- The purpose of this one-day seminar, held in April or May, is to prepare incoming Rotary club leaders for their roles.”

RIB 15.020 states:

“A district assembly, which may be a multidistrict assembly, shall be held annually, preferably in April or May, to develop Rotary club leaders who have the necessary skills, knowledge, and motivation to: sustain and/or grow their membership base; implement successful projects that address the needs of their communities and communities in other countries; and support The Rotary Foundation through both program participation and financial contributions.

The governor-elect shall be responsible for the district assembly. The district assembly shall be planned and conducted under the direction and supervision of the governors-elect. In special circumstances, the board may authorize the holding of a district assembly at a date other than provided herein. **Those specifically**

invited shall include the incoming presidents and the members of clubs assigned by the incoming president to serve in key leadership roles in the upcoming year."

3. The District Assembly should be a one day seminar (preferably) and be free or very affordable for all Rotarians.

4. The District Assembly should focus on training the incoming Presidents and club leaders.

5. The purpose of the DA is to provide knowledge, and motivation to: sustain and/or grow the membership base; implement successful projects and support The Rotary Foundation through both program participation and financial contributions.

6. The current programme of the DA does not fully achieve the aforementioned objectives and there are many distracting elements in a typical DA.

7. The Rotary Leadership Institute (RLI) provides an excellent interactive means for Rotarians with leadership potential to gain that knowledge in a discussion based environment. The objectives of the RLI programme is to develop at club level, as well as District Level, Rotarians with the ability to lead and capable of addressing and dealing with the issues for Rotary to continue to grow in its ability to provide service. The RLI has devised an extensive curriculum which would aid the training of Rotarians and Rotary leaders tremendously.

Resolution

IT IS HEREBY RESOLVED by the delegates of the 79th RI District 3300 Conference that all future District Assemblies in District 3300 commencing from the Rotary year 2015-16 should adhere to the following guidelines:

1. The District Assembly shall be conducted over the duration of one day only.

2. The District Assembly shall be an exclusively training event and shall focus only on the training of incoming club leaders to develop Rotary club leaders who have the necessary skills, knowledge, and motivation to: sustain and/or grow their membership base; implement successful projects that address the needs of their communities and communities in other countries;

and support The Rotary Foundation through both program participation and financial contributions.

3. The RLI programme and methodology be adopted as an aid to training to help develop at club level, as well as District Level, Rotarians with the ability to lead and capable of addressing and dealing with the issues for Rotary to continue to grow in its ability to provide service and to provide Rotarians wanting to gain an overview of Rotary with the necessary information and knowledge, imparted in a manner that is interesting and conducive to learning.

4. That within the next 5 years, the District should seek to use RLI Certified trainers to provide support and training at District level for the AGs Training, GDLTS, PETS, SETS, TETS and DA.

5. The incoming Presidents and the Board of Directors and those club members who have important leadership roles shall be specifically invited to attend the District Assembly.

6. The District Assembly shall be organized in a cost efficient manner and shall the registration fees shall not exceed RM200.00.

2. Resolution on Fund Raising for Rotary Events

Whereas:

There is presently a practice of raising funds to subsidise or defray the actual costs of Rotary events, such as District Seminars, District Assemblies, District Conferences, Rotary Institutes, etc. There is a need for greater clarity and transparency to ensure that members of the public are not confused about the ethos of our organization which is SERVICE ABOVE SELF.

Proposed Resolution

IT IS HEREBY RESOLVED by the delegates of the 79th RI District 3300 Conference that all appeal letters, leaflets and other correspondence for fund raising for District events should state specifically that the funds raised are being used for the specified event.

Dear Rotarians,

This is to announce that the TRF subcommittee have received a fresh supply of about 300 wheelchairs of various size. (see picture)



Clubs are encouraged to continue providing wheelchairs to the community by raising funds for TRF. Here are the steps:

1. Raise USD 100 and pay directly to TRF. Submit the receipt or acknowledgement to me by email and collect the wheelchair from my office at 225 Jalan Ampang by giving me at least 3 working days notice..by mail or sms
2. These wheel chairs come in hip side-to-side measurement from 14 to 22 inches wide. Please specify your need

Some Notes:

- Those who have paid for PHF, can claim 1 chair, and 10 for major donor. Top up to major donor can claim 1 wheel chair for each USD 1,000. These chairs will be given free.

- Those who donate to TRF Permanent Fund and Polio Plus can also claim 1 wheel chair free for each multiple of USD 1,000.
- Clubs that donate USD 1,000 worth of EREY will also be eligible for the wheelchairs free
- If your club has not given any money to TRF, then you are required to donate USD 100 for each wheelchair
- The scheme will be terminated automatically whilst stocks last and claims back-dated to IPDG Mansoor Saat's year will not be entertained

WHY the change in scheme?

Yes the scheme has changed. Rules will change depending on the source of funds.

This batch is paid from the districts DDF and D3600 Korea whereas in the previous batches, it was paid from PDG Jimmy Lim's funds.

DICTIONARIES

RESPONSE TO VIEWS EXPRESSED AFTER THE DISTRICT CONFERENCE

I was trying not to respond to the various views expressed after the conference but after the statement "the PDGs were playing politics," it deemed on me the need. There are many issues raised and they are:-

1. **Club Fund Raising during the conference**
 - Just look up on "Guidelines on Organising District Conference & Assembly," and all the guidelines are there.
2. **Balloting by clubs**
 - The procedures are as provided by RI.
 - Strict adherence and total compliance to the procedure with no ground for special consideration must be carried out. Merit of signatures of both club President and Secretary is obvious but if clubs feel signature of President should be sufficient, then propose to amend the code of policy.
 - Credential letter is to authorise the Rotarian to be the club elector.
 - Balloting is serious and legal matter and clubs have their role to play. Non-compliance and seeking special consideration is not right.
 - Governor must ensure that enough time for clubs to inform district if clubs didn't receive the ballot papers and clubs do likewise.
 - Non-compliance can lead to legal suits. Years ago, 5 ballots came late and after both reps of both candidates agreed to include the 5 late ballots, the losing candidate challenged the decision stating that he never gave his rep that power. He coincidentally lost by 5 votes.
 - Club leaders must take some efforts to comply with the rules as infringement can have far reaching consequences.
3. **Nominating Committee**
 - The Nom Com members are proposed and elected by the Clubs. They are not appointed. If they erred, then the clubs must also take responsibility.
 - The Nom Com scrutinises the CV of the candidates in more detail than the 2-page CV clubs get of the candidates.
 - Questions posed by the Nom Com are very deep and soul searching ex on membership: "Can you give us the names of Rotarians you introduced into Rotary?" and not "how many Rotarians have you introduced into Rotary?"
 - "Share with us what you did as .. (district community service chair or Interact chair.)" Nom Com does not take face value claims. Claims have to be substantiated.
 - Candidates' personal life, business involvement and financial standing are often probed very deeply. Thus it is wrong to assume that the Nom Com did not note the past set-backs like financial failings of the candidate.
 - Respect and reverence of the detail work of the Nom Com is vital. At least 2 PDGs have opted out of the Nom Com and more will follow if the trend continues. (A fact and not a threat.)
 - Asking the Nom Com to merely vet through the candidates and then present them to the clubs to vote is both uncalled for as this role could be done by the district secretary alone quite easily and does not need a committee of PDGs and past AGs to sit just for that.
 - Allowing clubs alone to vote and decide and doing away with the Nom Com is democracy but beware of the consequences.
 - Campaign though prohibited should not be "to win at all cost" like spreading falsehood.
4. **District Account**

On the district account, I would like to make some proposals with no direct reference to the accounts of this year or of the past. I believe we will need a Task Force to formulate guidelines on our district account and look at issues like:-

- The total income of the district should be the total amount Rotarians and Clubs pay to the district.
- Money received from other sources like Rotary Foundation, Disaster/Walkathon Fund Raising or excess fund carried forward must be accrued so that a true and correct final figure of profit or loss will be shown.
- Funds for specific purpose if not used must be carried forward. Example is our Disaster Relief Fund which all Rotarians pay. This fund if snowballed, will give us a large sum for future disasters. There are a few other such funds.
- The Governor Elect is provided a fund for the training events. In the past, each event has a budget but now the total amount is given thus leaving the governor elect to allocate as deemed fit. The same should be done for the governor. Then we will have 3 sections in the budget (1) DGE's Budget, (2) DG's Budget (3) Others like district conference subsidy, district secretariat subsidy, disaster relief, past governors' jewel etc.
- The financial support the Governor receives from RI should be incorporated into the main account. The money for official club visits is for the governor but the money for other items like the governor's news-letter should be reflected in the district account. If not, it will portray that the expenditure is taken from district fund but the income is excluded.
- The district treasurer must adhere strictly that the expenditure is within the budget approved by the DGEs at the district assembly.
- According to the law, the accounts are only for comments and club electors have with no rights to make amendments. This may discourage clubs to send electors in the future.
- Maybe a body be set up to go through the accounts before it is presented at the Berhad AGM for adoption. That body could be either a set of internal auditors and/or past governors' council and/or a list of Rotarians (PPs or Presidents) elected.
- Thus the need to re-introduce the Internal Auditors elected at the conference may have its merit now.
- There may also be a need to add a few members to the Berhad Board like a rep each from the PDGs, the Club Presidents and a Rotarian (preferably a PP) with accounting background all to be elected at the AGM (Conference.)

5. PDGs Playing Politics

- PDGs are often placed in a very awkward position of "serba salah."
- Many believe the PDGs have the powers in the administration and policy making but in reality, the PDGs do not have any such powers. The power is with the DG alone.
- When an issue arises, many expect the PDGs to provide the advice/information whilst just as many believe that the PDGs should not interfere as clubs are autonomous. "Serba salah" again.
- Many consider the PDGs like the Cabinet who discusses every issue of the nation and thus they speak with one voice. PDGs individually receive the same, if not less information, as all club leaders. There are no avenues for discussion and consensus to "sort out their differences first."
- Most Rotarians in the district are not fully aware of District & RI policies. A few PDGs often speak up at the conference and assemblies to enlighten the Rotarians.
- Should PDGs stop highlighting issues that are not in order?

I strongly believe that many of our Rotarians, including some club leaders, are not very well versed with Rotary's code of policies. It may be useful to have a forum at the next assembly or conference for all Rotarians to submit their questions to a panel of senior Rotarians who can then try to provide the clarifications. At the same time, the forum can also have a healthy exchange of views.

I have refrained from quoting names as it is not my intention to challenge anyone's views. If you have any views and need to respond, if possible then just respond to me as I do not want to drag the whole District into this debate.

NELSON MANDELA & POLIO

In 1996, routine polio immunizations in Nigeria and other African countries were anything but routine. Competing health priorities and lack of funding hampered many governments from putting polio eradication high on their agenda. The drive for a polio-free Africa needed a playmaker.

Enter Nelson Mandela. Herb Brown, Rotary's president in 1995-96, recalls seeking the South African leader's support.



"President Mandela was so gracious and listened as we described the problem," Brown says. "I told him only he had the influence to persuade the countries to resume immunization."

Mandela agreed to help. "I'm well aware of Rotary and all the work you've done, and all the work you did while I was in jail," he told Brown. At a press conference, with Brown at his side, Mandela asked all the heads of state in Africa to open their doors to polio National Immunization Days.

Mandela helped launch the Kick Polio Out of Africa campaign later that year with 1996-97 Rotary President Luis Giay and Rotary Foundation Chair Rajendra Saboo. Almost immediately, Africa's polio eradication effort was back on track. Using soccer matches and celebrity endorsements, the campaign raised public awareness of polio and helped spur more than 30 African countries to hold their first National Immunization Days.

In recognition of his vital work, Rotary presented the Rotary Award for World Understanding to Mandela in 1997, then Rotary's highest honor. "We chose President Mandela because of his significant contributions to world peace, human rights, and freedom," said Giay,

adding that Rotary members especially appreciated "his strong support of the eradication of polio throughout Africa."

Mandela called the award "a tribute to the people of South Africa's rainbow nation." Rotary's work toward eradicating polio "has shown the power of a global network of people who are ready to roll up their sleeves and put their heart and soul into saving children from disability."

Mandela donated the award's \$100,000 prize to the Nelson Mandela Children's Fund.

Following his death, Rotary members in South Africa lauded Mandela as "one of the 20th century's iconic symbols of freedom and equality," "the father of the nation," and "a leader of service."

"Mandela was a man who overcame unimaginable hardships to emerge as one of the greatest leaders of our time" and one of our greatest humanitarians [His] legacy of courage, determination, and commitment will forever inspire us to move forward in our effort to achieve a better, more peaceful world," said [Rotary President Ron Burton](#).

Rotary made polio eradication its top philanthropic goal in 1985. As the volunteer arm of the

[Global Polio Eradication Initiative](#) (GPEI), Rotary has contributed more than US\$1.2 billion and countless hours of volunteer service to ending polio. This includes nearly £20 million contributed by more than 53,000 members of Rotary clubs in the United Kingdom. To date, more than two billion children have been immunised against the paralysing and sometimes deadly poliovirus.

The Duke of Edinburgh, Prince Philip, has been an Honorary Member of the Rotary Club of Edinburgh since 1952 and last visited the club in 2007.

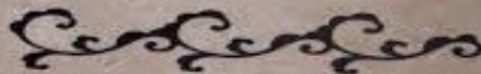


